SUB: - LEVY OF INFRASTRUCTURE CESS THROUGH ELECTRICITY BILLS.

Respected Sir.

Jalandhar Chamber of Industries & Commerce (Regd) would like to draw your kind attention on the above subject and strongly represent our resentment against the levy of infrastructure cess to the tune of 5% on energy bills of all consumers which is totally unfair & unjustified to the people of Punjab.

Govt. knows very well that now-a-days the business is quite slow. Industrial productions have gone tremendously down. There is no customer in the market either for Industry or Traders or Reality Business. Till now industry and trade couldn't comes out of the burden of entry tax which State Govt. imposed on almost all Industrial Inputs and crores of rupees have gone to the treasury. Now neither Industry nor traders or any common man will accept the increase in the Electricity Duty in the name of Infrastructure Tax. It is not out of place to mention here that:-

- PSPCL can not collect the infrastructure cess because PSPCL never uploaded the infrastructure act on their website from which consumers Should come to know that how and why this cess is being imposed on them.
- PSPCL determine their energy selling rate only after considering 20% ± cross subsidy, wages of their employees and adding their infrastructure expenses. Hence infrastructure expenses of Powercom are already included in the cost.
- 3. Coal is the major raw material of Powercom and they pay 10% VAT on the purchase of Coal to the State Govt. which is included in the cost. And on sale of energy to the consumer Powercom charges Electricity Duty @13%, VAT @10% and Octroi @2%. Technically Punjab Govt. should refund VAT to the Powercom charged on the Purchase of COAL. And it shouldn't be included in the selling rate of electricity.

4. Electricity is the major raw material of Industry. And again VAT charged in the energy

bill should be refunded to the Industry. Also this is a matter of double VAT collection on Electricity bills. Now we ask the Govt. when already industry paying tax to the tune of 25% on bills, how you can impose another Jajia Tax in the name of infrastructure cess.

We would also like to bring into your kind notice that JCIC protest in advance against the forthcoming levy of cow cess and the levy of another cess in lieu of water & sewerage charges. If it is done it will be another step motherly treatment of the Government towards the people of Punjab.

Now JCIC in one voice request your good self to abolish the infrastructure cess and do not levy any cow cess & any other cess through back door (Energy Bills). We are sure that your good self will understand the problems of Industry & General public as they are unable to bear these burdens and hope your good self will take personal interest to abolish these levies at the earliest.
