Respected Sir,

May we draw your kind attention towards contribution of industries department to promote the MSME in Jalandhar. We are very sorry to say that the entire department use to organize meetings only which is purely eye-wash and no follow-up is there to fulfill the commitments made by higher officials or the ministers with the industry. Development projects are being approved/ sanctioned but funds are not released. Here we give example of the project "Requirement for strengthening and widening of road at Dhogri Industrial Park, Pathankot road, Jalandhar. This project is pending since March-2017. Finally this project was sanctioned by yourself on June-2017. During that meeting with the Industry at Hotel President Jalandhar yourself also announced that "I approve the project & the required amount of Rs. 2.95 Crores will be release very shortly". But till date even after visiting Chandigarh more than 20 times and writing hundreds of letters to the officers, Hon'able Ministers of Industries ,PWD ,Finance & CM Office, We get non else then only assurance that your project is approved and funds are being release shortly. Kindly go through the potential of industrial growth at Dhogri Industrial park. The Highlights are,

- That Dhogri Industrial Park already declared Industrial zone in Master plan 2031.
- That a dozen of Industrial Units already running there.
- That 30-45 Industrial Units have purchased land in that area to set up new manufacturing units.
- That few of them have already get CLU from PUDA to install new Industrial Unit.
- That 15 industrialists have already signed MOU in the presence of the Principal Secretary Sh. Rakesh Verma to setup new industrial units there.
- That this area has the capacity to set up more than 100 new Industrial units.
- That above 5000 unemployed youth will get job there.
